

Shareholder Meeting Notice

Northeast Bancorp's Annual Meeting of Shareholders will be held on Friday, November 17, 2017 at the offices of Goodwin Procter LLP located at 100 Northern Avenue, Boston, Massachusetts 02210 at 10:00 a.m., Eastern Time.

Proposals to be voted on at the meeting are listed below along with the Board of Directors' recommendations.

The Board of Directors recommends a vote FOR all nominees listed in Proposal 1 and FOR Proposals 2, 3, and 4:

- To elect the two nominees named in the proxy statement as Class I directors, each to serve for a three-year term and until their respective successors are duly elected and qualified.
- 2. To approve, on an advisory, non-binding basis, the compensation of our named executive officers.
- 3. To ratify the appointment of RSM US LLP as our independent registered public accounting firm for the fiscal year ending June 30, 2018.
- 4. To ratify the Northeast Bancorp Amended and Restated 2010 Stock Option and Incentive Plan.
