Northeast Bank's Annual Meeting of Shareholders will be held on Monday, November 22, 2021, 12:00 P.M. Eastern Time, at Northeast Bank, 200 Berkeley St., 17th Floor, Boston, MA 02116. Shareholders may also vote their shares and participate virtually at the annual meeting by visiting <https://meetnow.global/M97LKZD>. To access the virtual meeting, you must have the information that is printed in the shaded bar located on the reverse side of this form.

Proposals to be voted on at the meeting are listed below along with the Board of Directors' recommendations.

The Board of Directors recommend a vote FOR all the nominees listed and FOR Proposals 2 and 3:

1. To elect the two nominees named in the proxy statement as Class II directors, each to serve for a three-year term and until their respective successors are duly elected and qualified.
2. To approve, on an advisory, non-binding basis, the compensation of our named executive officers.
3. To ratify the appointment of RSM US LLP as our independent registered public accounting firm for the fiscal year ending June 30, 2022.
